Treasurer's CORNER Pledge receipts during December 2025 were healthy. 2025 full-year pledge receipts were a little less than in 2024 and our forecast. Other unrestricted receipts were good and helped cover everything. Expenses were in line with expectations. Unrestricted cash at the end of the year was enough to cover about 6 weeks of expenses – a good end to the year.

The Church has pending capital needs to maintain our buildings and infrastructure: the Rectory needs re-roofing; the Sanctuary must be tented again for termites; the metal beams on Carlton Hall & school building wings require rust remediation & painting; and the irrigation system needs renovation and repair.

Advance commitments and receipts thus far are sufficient to get started. Please prayerfully consider contributing to the effort. Designate gifts to the Building Fund.

Donations from Individual Retirement Accounts- Parish members at least 70 ½ years of age may treat donations made directly from an Individual Retirement Account (IRA) to the Church as a nontaxable IRA distribution. Such a transaction is called a Qualified Charitable Contribution (QCD). A QCD is excluded from taxable income and counts towards a required minimum IRA distribution (if a distribution is required). The donation cannot be claimed as a deduction because the distribution is excluded from taxable income. The Church will provide the appropriate acknowledgement for tax documentation. For more information, see IRS Publication 590(b) available at irs.gov and consult with your tax advisor and IRA Trustee.
